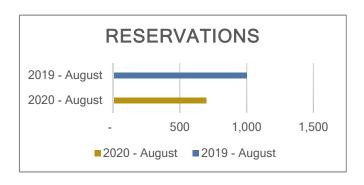

Campsite Reservations

- Reservations reopened on June 18, 2020
- 3,446 new campsite reservations were made in July 2020, compared to 1,798
- This is an increase of 48% from July 2019



Administration

- Recruitment and Staffing
 - Two Park Maintenance Workers I-II have been hired and are expected to start employment on September 1, 2020
- Budget 2021
 - 2021 Draft Budget will be presented to the Board of Control at a Budget Workshop Special Meeting on Wednesday, August 19, 2020
 - DPRA will present the Proposed Budget for approval at the regularly scheduled quarterly meeting on September 24, 2020

<u>Capital Projects</u>

- Fish Cleaning Stations
 - Expected delivery Q3 2020
 - Expected install Q3-Q4 2020
- Swimming Lagoon Filter Replacement
 - o Construction is expected to begin mid-August 2020

Operations

- Due to COVID-19 and physical distancing, staff has continues on customer safety and security as well as daily infrastructure maintenance
- Currently our operations include access for Day Use, Camping, and Lakeshore Camping.
- Camping in developed areas are by reservation only with reservations currently being made through our website or by phone call to our Visitor Center.
- The Swimming Lagoon will remain closed for the remainder of 2020 but is expected to reopen for the 2021 season without delay

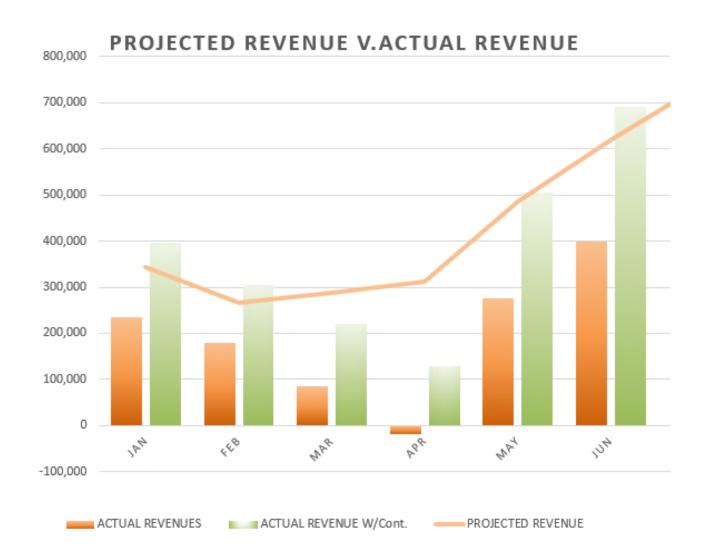
PROJECTED REVENUE V.ACTUAL REVENUE

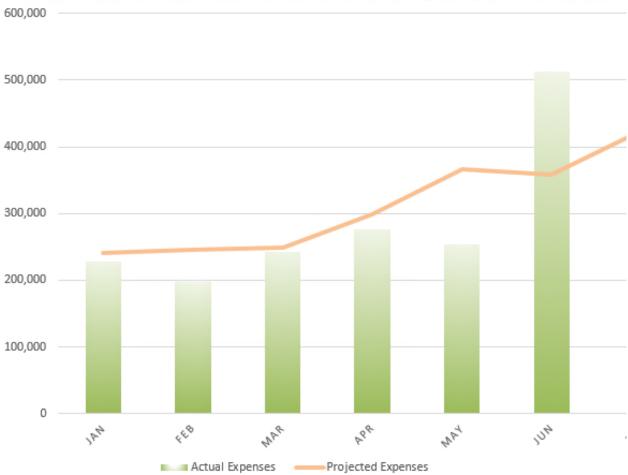

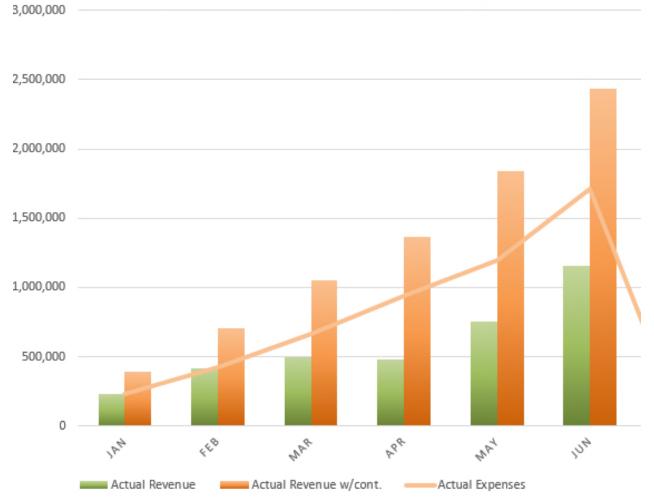
