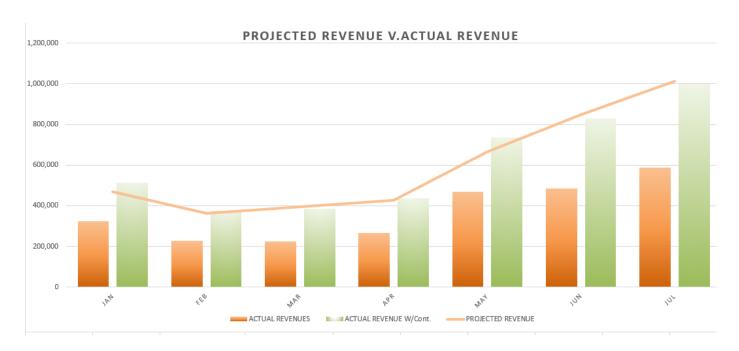
- Roadwork Currently in progress

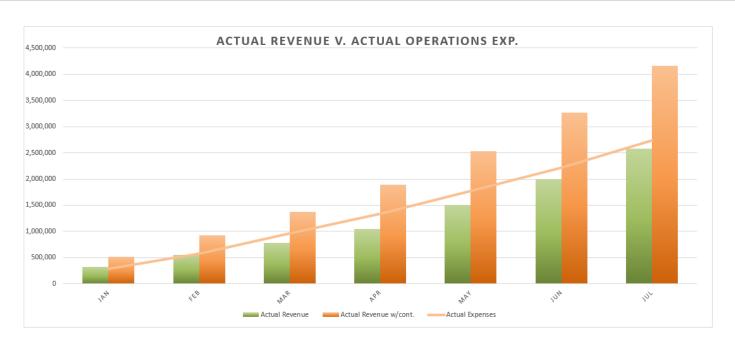
