**INSTRUCTIONS:**

This permit application form is intended for the use of the Recreation Agency to *consider* authorization of Recreation Area use for purposes other than family camping and individual water-oriented use. Individuals and groups of various sizes that wish to use the facilities in ways that may alter the normal operation of the Recreation Area will need to complete the following information.

Upon submission of this form to the Recreation Agency, it will be reviewed and if authorization is granted for the items requested in this form, a Special Use Permit will be issued. The Special Use Permit is issued solely for the activities described in the Special Use Permit. Appropriate facility use fees will be assessed. In addition to a Special Use Permit, the Permittee must submit to the Recreation Agency a certificate of liability insurance for the described special use for an amount to be determined, and must have the following wording added to the certificate: *The Don Pedro Recreation Agency, the Turlock Irrigation District and the Modesto Irrigation District, and their governing boards shall be named as additional insureds under this policy.*
